What is this product?

Type:

This product is a share of an investment company qualifying as an alternative investment fund (AIF) submitted to Luxembourg specialised investment fund law.

Objectives:

To achieve long-term capital appreciation by gaining exposure to equity markets worldwide.

The sub-fund will obtain indirect exposure through the use, inter alia, of UCIs pursuing traditional or non conventional equity strategies (including funds of funds and master/feeder funds), ETFs or financial derivative instruments, the performance of which is linked to equities.

The sub-fund may also obtain direct exposure by investing directly in equities and equity like securities.

The sub-fund may, on an ancillary basis, invest in bonds, loans and other debt claims and money market instruments of issuers worldwide.

The sub-fund may use derivative instruments for investment and hedging purposes.

The intended investment horizon is at least 5 years.

This product was launched in 2013.

The currency of the product is expressed in EUR.

This product is a capitalisation product meaning that income and capital gains are reinvested.

Intended retail investor:


Investors looking for capital appreciation and who have a high tolerance for risk and volatility. Investors should be ready to hold the fund for at least 5 years and ideally 7 years.

Term of product:

This product has no maturity date. However, the manufacturer may decide to close the product under certain circumstances.

What are the risks and what could I get in return?

Risk indicator:



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Costs over time

Recommended holding period: 7 years
